WHAT IS PARASITE THERAPY?

Parasite Therapy is a powerful, broad spectrum anti-parasitic, anti-microbial, and anti-fungal herbal cleansing program.

HOW IT WORKS

Parasites are defined as 'any organism that lives on, or in, the body of another organism'. Parasites which live inside the human body will feed off of our cells, the food we eat and even the supplements that we take. Other similar organisms include microbials which are microscopic parasites (such as bacteria), and fungus (yeast) which are a diverse group of single or multi celled organisms, that live by decomposing the organic material in which they grow. As parasites can live anywhere in the body, they can affect many of the body's systems. Therefore, ridding the body of parasites is extremely important for good health.

Anti-parasitic herbs rid the body of parasites in 2 different ways; One group of herbs works by paralyzing the organism directly, allowing the body to remove it through the regular channels of elimination. Another group of herbs works by directly destroying the organism. Parasite Therapy is a formulation for cleansing parasites from the body, but is also powerful enough to eliminate yeast (candida), as candida often co-exists with parasites. *(NOTE: For patients with Candida only, please use our Candida Therapy cleansing kit instead).*

DIRECTIONS FOR USE

Take 3 capsules of Parasite Therapy I with 1 cup (250ml) of water and 1ml of Parasite Therapy II in the morning. Take 3 capsules of Parasite Therapy I with 1 cup (250ml) of water and 1ml of Parasite Therapy II in the evening. Take for 15 days, followed by a 5 day rest period, and then continue for an additional 15 day period (additional Parasite Therapy Kit required).

NOTES:

- Parasite Therapy II dropper dispenses 0.5ml when filled to line indicated.
- This regiment can be repeated as necessary, which may be required in conditions which are severe. Parasite Therapy can also be taken as a preventative measure periodically (once or twice per year)
- If the patient experiences cleansing reactions, the program can be used at half the dosage (evening dose only).
- If patient is less than 150 lbs, the program can be used at half the dosage (evening dose only).
- It is extremely important that the patient take the 5 day rest period in between the two 15 day periods. This allows time for parasite eggs to hatch, in order for them to be destroyed in the second 15 day cleansing period.

WHAT TO EXPECT

There may be symptomatic aches, pains, cramps and upset stomach etc. at the beginning of the program. These may intensify in the first 4-7 days and then begin to subside. The results will range from increased energy to alleviation of symptoms.

SUPPORT PRODUCTS

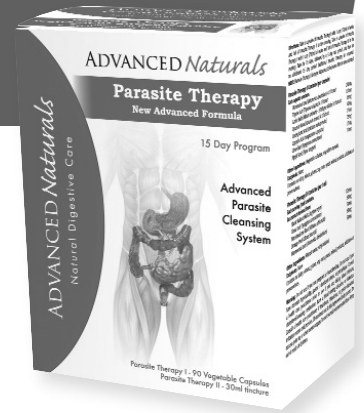
FibreMAX: It is important when cleansing to ensure that fibre intake is at an optimal level (30-40 grams). Fibre absorbs parasites and their toxins so they can be eliminated from the colon. It is recommended that you use FibreMAX as directed on the label as part of your cleansing program and as maintenance afterwards.

ParaZYME: ParaZYME is a digestive enzyme blend with hydrochloric acid. Hydrochloric acid (stomach acid) is the body's first line of defence against organisms entering the body via food (i.e. bacteria, parasites). If Hydrochloric Acid production is low, then parasites can move into our bodies and grow quickly. ParaZYME can be used daily to ensure that the intestinal environment is not conducive to future parasite infestation, as well as to help with the digestion of food.

AFTERCARE MAINTENANCE

Ultimate FloraMAX: Probiotics are 'friendly' bacteria which help to ensure a healthy balance between 'good' and 'bad' bacteria in the intestinal tract. Ultimate FloraMAX's 50 Billion culture formula contains therapeutic amounts of Lactobacilli and Bifidobacteria to help create a balanced intestinal environment in both the small and large intestine.

Intestinal Therapy: Parasites can cause major damage to the intestinal tract lining. This damage allows toxins, free radicals, and other pollutants to enter the body more easily, which is the first step towards chronic disease. It is extremely important that the intestinal tract lining is healed once you have completed your parasite program.



What does it contain?

PARASITE THERAPY I

There are several categories of herbs / minerals that are used in Parasite Therapy part I:

Anti-Parasitic Herbs

- ♦ Wormwood Leaf
 - ♦ effective against nematode infestation particularly *Enterobius*, *Ascaris lumbricoides* and *Trichostrongylus colubriformis*. Also effective against acute intestinal amebiasis, caused by the parasite *Entamoeba histolytica*.
- ♦ Quassia Wood
 - ♦ effective against malaria.
- ♦ Garlic Bulb
 - ♦ effective against *Cryptosporidium* and protozoan's such as *Entamoeba histolytica* and *Giardia lamblia*.
- ♦ Clove Bud
 - ♦ shown to be 7.3 times stronger than the antiparasitic drug piperazine, used to treat pinworm and roundworm infections in humans.
- ♦ Pippli Seed
 - ♦ an ayurvedic pepper which is effective against *Giardia lamblia*.
- ♦ Thyme
 - ♦ contains thymol and carvacrol which have anthelmintic properties (expels intestinal worms).

Antibacterial Herbs:

- ♦ Garlic Bulb
 - ♦ strong antibacterial activity even against multidrug resistant strains of *E. coli*.
- ♦ Clove Bud
 - ♦ effective against *E. coli*.
- ♦ Quassia Wood
 - ♦ effective against *E. coli*, *Streptococcus faecalis* and *Staphylococcus aureus*.

PARASITE THERAPY II

There are several categories of herbs that are used in Parasite Therapy part II:

Anti-Parasitic:

- ♦ Black Walnut Hulls
 - ♦ the fresh green hull has traditionally been used as a vermifuge (expels parasites), particularly to remove ringworms.
- ♦ Clove Bud
 - ♦ shown to be 7.3 times stronger than the antiparasitic drug piperazine, used to treat pinworm and roundworm infections in humans.
- ♦ Wormwood Leaf
 - ♦ wormwood in an alcohol extract strongly inhibits growth of the protozoa; *Naegleria fowleri*.

Anti- Fungal Herbs:

- ♦ Black Walnut Hull
 - ♦ contains juglone which is effective against *Candida albicans*, *Saccharomyces cerevisiae*, *Helminthosporium sp.*, *Pycnoporus sanguineus*, and *Trichophyton mentagrophytes*.
- ♦ Clove Bud
 - ♦ contains antifungal properties.
- ♦ Orange Peel
 - ♦ effective against 12 different fungal strains.

Anti- Fungal Herbs:

- ♦ Caprylic Acid
 - ♦ an organic fatty acid, which has been used as an antifungal for over fifty years.
- ♦ Undecylenic Acid
 - ♦ a mono-unsaturated fatty acid. A potent antifungal that has been shown to be 11 times stronger than Caprylic Acid.
- ♦ Garlic Bulb
 - ♦ garlic extract and its constituents diallyl disulphide and allyl alcohol have anti-candida properties by triggering apoptotic cell death to yeast organisms.
- ♦ Clove Bud
 - ♦ contains antifungal properties.
- ♦ Thyme Leaf
 - ♦ contains the constituent thimol, which is a strong anti-fungal.
- ♦ Quassia Wood
 - ♦ effective against *Aspergillus niger*.

Antibacterial Herbs:

- ♦ Clove Bud
 - ♦ effective against *E. coli*.
- ♦ Black Walnut Hull
 - ♦ contains juglone which is effective against *Staphylococcus aureus*, *Bacillus subtilis*, and *Mycobacterium smegmatis*.
- ♦ Orange Peel
 - ♦ effective against 22 different bacterial strains.

Intestinal Soothing Herbs:

- ♦ Marshmallow Root
 - ♦ has demulcent properties (relieves internal inflammation).

Undecylenic acid (calcium undecylenate)	75mg
Caprylic Acid (magnesium caprylate)	75mg
Clove Bud (<i>Syzygium aromaticum</i>)	25mg
Pippli Seed (<i>Piper longum</i>)	10mg

Other Ingredients: Vegetable cellulose, vegetable capsules

Excipients: None

Orange Peel (<i>Citrus sinensis</i>)	50mg
Wormwood Leaf and Stem (<i>Artemisia absinthium</i>)	50mg

Other Ingredients: filtered water, ethyl alcohol

Excipients: None
